This Release constitutes the entire agreement between myself and Wizards with respect to this matter, supersedes all other oral and written representations, understandings or agreements relating to the materials, and may not be amended except by written agreement signed by the parties.

This Release shall be constructed and controlled by the laws of the State of Washington (without regard to the conflicts of law provisions therein). Any dispute under this Release shall be submitted to arbitration with Judicial Dispute Resolution LLC in Seattle, Washington. The arbitrator shall have authority to award reasonable attorney’s fees and costs incurred to the substantially prevailing party.

I understand Wizards is conducting such activities in express reliance upon the foregoing, and I represent and agree I am free to grant the Rights granted to Wizards hereunder.
